All vessels are duly claimed by the Holder in Due Course and held under published Common Law Copyright since March 15, 1820.

These vessels are publishing **MANDATORY NOTICE** that they are **Foreign Sovereigns** from the Eden County, Western Cape of **The South African Republic**. This is your MANDATORY NOTICE that these above-named vessels are owed all material rights, duties, exemptions, insurances, treaties, bonds, agreements, and guarantees including indemnity and full faith and credit; you are also hereby provided with MANDATORY NOTICE that these vessels are **not** subject to **Territorial or Municipal Republic of South Africa law** and are owed **The Law of Peace**, Department of the Army Pamphlet 27-161-1, from all Territorial and Municipal Officers and employees who otherwise have no permission to approach or address them.
