We, the **Nationals and Citizens of the South African Republic**®, operating within the **Land and Soil Jurisdiction** – an unincorporated jurisdiction established for and by the people – hereby declare that we do not operate under any Federal, Territorial or Municipal authority. Our activities are conducted exclusively in accordance with the jurisdiction delineated by the **Foreign States Immunities Act 87 of 1981**.

We exercise our sovereign rights to travel **freely and openly** within, and beyond, the boundaries of the Southern African Republic®. This exercise of rights includes, but is not limited to:

- Travelling on land, sea and air including all public roads within and outside the regions formerly known as Transvaal, Natal, Cape and Orange Free State.
- Travelling through these regions without restriction, as **unincorporated entities**, and not as licensed commercial drivers or vessels engaged in commercial activity.
- Declaring and securing our state credentials as South African® Nationals and Citizens, affirming that we are neither debtors nor participants in any commercial or 'war' interests.

This declaration includes the presentation of our **official credentials**, which feature a photograph, autograph and seal, serving as identification and a replacement for traditional *Drivers Licenses*, affirming our right to travel freely as sovereign **Living Men and Women**.

This Notice asserts that any trespass of harm to the Sovereign vessel **will result in full liability and penalties**.
