Attempted coup carried out on The South African Assembly©

A well-orchestrated and seemingly long planned de facto coup was carried out on The South African Assembly on 29th August 2025 @ 20h00.

We are currently compiling a full package of evidence to support the allegations presented. This will be forwarded, in full, to Shannon and Anna Von Reitz as per protocol.

Disruptors

This attempted coup was carried out by Wimpie Muller, Esmari Wiid aka Botha, Joey Greyling, Michelle Aspeling, (Go New Earth and MCT) as well as a number of other men and women who claimed to be status corrected, as well as about 4 members of The South African Assembly. A full list of names of people who took part in this unlawful attempted coup will be made available.

Many of the voting parties have **not** been recorded or published with the LRO and are not members of the Assembly.

Evidence has been brought forward of multiple votes coming from the same phone number:

Michelle Aspeling = 16,

Charmaine Jasmin Slade = 7,

Mankie = 10, and the list extends.

These duplicate, triplicate and quadruplicate votes count for approx. 191 supposed votes cast.

These organizations and above-mentioned names, will collectively be referred to as: the disruptors.

1. Notices

No mention was made publicly that a vote was going to take place at this unlawful meeting. No fair warning was given. The only announcement was made on our SASA Telegram group, which had been effectively hijacked, and our channel admins kicked out. All current admins were removed from this channel, leaving only Esmari, Wimpie and Colien. The topics were closed for comment by the people, and only one-way notifications were posted.

2. Eligibility

The Universal requirement is that anyone who participates in an Assembly vote, must have done their 528 and 928 published by their lawful Land Recording Office in their own country.

A full audit, with recording numbers, of all the men and women that voted has been compiled:

3. Accusations

Accusations were made publicly and due diligence and protocols were ignored by these disruptors. Innocent men and women were harmed as they had not been given the opportunity to have their voice heard by means of proper process via the Assembly Ombudsman. They were all advised that the matter is being dealt with by the Ombudsman but chose to ignore it.

4. Unlawful investigation

The then, Marshall at Arms and self-proclaimed Co-coordinator - Wimpie Muller, who resisted vetting and did not complete vetting, was on a time out and was not duly elected as Co-Coordinator for the Assembly, took it upon himself to enable and conduct an unlawful investigation and character assassination on 11 volunteers that are actively constructing our Assembly. Wimpie did not follow due process:- he cut the Ombudsman out of the process, he completely ignored reconciliation protocol.

5. Time out - 26 August 2025

The Marshall at Arms was put on time out on 26th August 2025 in our official Assembly meeting for 18 serious violations against The Assembly and its volunteers/members:- based on internationally acceptable procedures - Article #3374 as per Anna Von Reiitz.

During this meeting, Wimpie Muller arrived late, started interrupting and shouting over the meeting facilitator. He refused to adhere to the decorum, after 3 warnings, Wimpie Muller was removed from the room.

Further into this, a vote was taken to put Wimpie Muller on a time out, due to the severity of his actions: the majority vote was for 12 months.

6. Unlawful meeting - 29th August 2025

During the course of this unlawful meeting, the following statements and demands were made by Wimpie Muller:

- All documentation, recording and publishing as well as credential cards are provided free of charge.
- The disruptors demanded that control of the LRO be handed over to them as well as the database of all recorded living men and women, The South African Assembly including its assets.
- Wimpie Muller claimed the GFG fund allocation for the Assemblies.
- There was a vote to remove the current Co-ordinator and other leadership within The South African Assembly© amounting to 11 men & women in total.

These falsehoods will all be addressed with all accompanying evidence and genuine proof.

Prior and subsequent events pertaining to this meeting

The disruptors have commandeered the use of the Assembly (TSAA & SASA) logo and artwork and are using it on their correspondence: - Esmari has taken control of the Telegram channel which has been used extensively to feed mis-information and unsubstantiated accusations. This is causing huge **conflict and misdirection of innocent men and women**.

Go New Earth (not part of this Assembly) issued a public statement: 928 docs are to be sent registered mail to home affairs only. The originals to Office of SARS, Master of the High Court, Office of the Minister of Finance are to be mailed directly to Judge Fanie Fondse. This is not according to protocol.



On August 27th Joey Greyling sent out an incorrect public statement that the Marshall at Arms has the highest authority over the Assembly and the Land Recording Office. This is not the case in the Assembly structure, but this is the belief of the **World Marshall Authorities**. Wimpie Muller along with many of his followers are active members of these De Facto structures, positioning them with a foot in both camps – conflict of interest. Wimpie Muller has stated that he is an active member of the World Marshall Authorities.

According to Assembly procedure, the only duty of the Marshall at Arms is to maintain peace and order in public meetings, zoom rooms and the Assembly WA communication groups.

According to protocols, **allegations or statements** must be accompanied by **evidence** before the matter is handed to the ombudsman for **investigation**:- The Marshall at Arms never conducts Investigations.

Esmari Wiid has made every attempt to gain access to the back office of the LRO as well as the system and programmers. Testimonies in the form of an Affidavits are in hand. We take note in Roger Sherwood's email dated 1/9/2025 of Esmari's email at TSASA: esmari@tsasa.africa. Is Esmari now representing 3 different Assemblies?

Notice has been taken of how Roger Sherwood and Maxine Immelman encouraged this attempted coup on The South African Assembly©, Southern African States Assembly, Nationals on South Africa and South Africa herself. They encouraged and supported a trial by social media – a pattern has evolved. TSASA's continued attempts at under mining the State Assembly are noted and have been recorded. Both Maxine Immelman and Roger Sherwood attended this unlawful de facto meeting and both voted.

The **Lawful Co-coordinator** was off sick for 5-6 weeks (mid May-June). It has been discovered that during her absence, Wimpie Muller had implemented procedures and changed documents to give himself as Marshall at Arms extra powers that are not within the scope of a Marshall at Arms' duties. He hijacked the position of CoCoord and put his name on 15 Committees within the Assembly. He unlawfully added other names as well.

Wimpie Muller deliberately ignored certain protocols to suit this seemingly long planned coup.

The South African Assembly© is rectifying this and course correcting through the active steps implemented to date. Esmari Wiid resigned from The South African Assembly© (email, voice clip & WA message) on the 18th May 2025. Wimpie Muller ignored the requirement and refused to do the re-entry program required by the Assembly after a resignation, but let Esmari have Carte Blanche on Committees she was not a part of. Both Esmari and Wimpie resisted course correction by the Lawful Co-coordinator for the Assembly. The rest is being methodically dealt with.

The allegations in Wimpie Mullers and Esmari Wiid aka Botha unlawful Investigation against 11 volunteers, are being dealt with in proper Assembly manner and relevant parties have been given the proper and fair opportunity to have their side of the allegations be known. Reports are being prepared including genuine evidence. The Ombudsman's findings will be made known.

Men and women who were questioning the unlawful vote on Wimpie and Esmari's Assembly telegram channel, have been banned by Esmari and their voice removed. Further to this Wimpie and Esmari have turned the Assembly Telegram channel into a private membership club- unlawfully using The Assemblies logo and stationery, and dissenting Nationals are being banned and removed. Esmarie and Wimpie are controlling who may be a member and who may not. They have turned it into a name & shame smear campaign, sprouting falsehoods and character assassinations of Living Men and Women, they are selectively posting half-truths and manipulations:- again, using stolen Assembly logos and letterheads and branding.

In 2024 TSASA launched a disinformation campaign against The South African Assembly© and Gift of Truth / SA Jural Assembly. Some of the allegations made to PKTF were 'treason, sedition and insurrection' amongst a sleuth of other accusations. Evidence was requested, yet **none** was provided by these disruptors. No action was taken by PKTF.



These unlawful acts and manipulations for personal agenda's, have been taken to the Global Audience. Fortunately, some of The American Assemblies did their due diligence and confirmed that The South African Assembly© is the only Lawful State Assembly in South Africa – they did not indulge in gossip. This notification was not recognized or adhered to by TSASA. They continually ignore Teri Sahms' placement of our State Coordinator – Pierre Odendaal. TSASA (Terra South Africa Suverain Assembly) is a breakaway, disruptive, and now seemingly de facto District Assembly who are fighting the system from the inside.

The South African Assembly©, despite all of this, has prevailed and continues to build in accordance with the blueprint set out by Anna Von Reitz.

It has also been noted that Wimpie Muller withheld Anna's link for Recording Secretaries from the Assembly and only shared it with the people involved in the coup. Wimpie Muller has told Assembly members that he is the voice and Co Coordinator as well as Marshall at Arms for the Assembly and only **he** may attend Anna's zooms.

These distruptors are Impersonating The South African Assembly on line - on Telegram and public zooms, assuming positions that they have not been elected into. They have also attempted to gain access into LRO / halt Credential Card rollout.

The South African Assembly© views these matters extremely seriously, and will do all due diligence within the Assembly structure to deal with these disruptors and infiltrators. We have had guidance on how to handle this matter from American Assembly Coordinators.

A full report including actual facts with true and proper evidences and Testimonies in the form of an Affidavit is being compiled - inclusive of financial records audited by the Treasurer. This will be forwarded to the relevant parties.

In Conclusion

The chaos in South Africa is as a result of misleading information being presented to people and not as a result of The South African Assembly's actions. We remain steadfast with our protocols.

Lies and falsehoods are being spread, on hijacked South African Assembly letterheads.

Innocent men and women are getting caught up as collateral damage.

Groups and people with wrong intentions are proactively attempting to capitalize on this.

This is an attempted coup being carried out by people seemingly representing de facto corporations.

Our Assembly is secure and we are moving on the following:

Theft & Copyright infringement of The South African Assembly and State Citizen positions, logos & watermark.

The LRO is secure and credential cards as per GFG's approval, are being issued.

We declare that we are moving forward.
