



Clarification of Identity, Status and Record

To all men and women acting in good faith in pursuit of liberty, dignity, and lawful self-determination:

This notice is issued in the interests of transparency, accuracy, and the protection of lawful work conducted in service to the people.

After extended restraint and attempts at correction, it has become necessary to place the following matters formally on record:

1. Lawful Identity of The South African Assembly

The South African Assembly is the lawful South African Assembly.

This status has been in effect since the appointment of Pierre-Charl Odendaal as Coordinator in February 2024.

2. Record of Hostile and Misrepresentative Actions

TSAA has been subjected to coordinated attacks, misrepresentation, and reputational harm on national and international platforms by the following individuals and certain associates:

- **Wimpie Muller** – *Expelled former Marshal-at-Arms of TSAA.*

Investigation and Ombudsman reports are publicly available on the Land Recording Office website.

He produced and circulated a complaint document containing false and fraudulent information, used to threaten and discredit TSAA and its associates.

- **Esmarie Wiid (Botha)**

Former TSAA volunteer who collaborated with Wimpie Muller in attempts to stage a coup within TSAA and to disseminate false information regarding the Assembly, its volunteers, and associates.

Relevant investigation and Ombudsman reports are likewise publicly available via the LRO.

- **Joey Greyling** – *Director of Go New Earth.*

Actively involved with Wimpie Muller and Esmarie Wiid (Botha) in discrediting TSAA and its associates.

She claimed that she and an individual referred to as “The Judge” controlled the distribution of GFG funds in South Africa, and that individuals who questioned or spoke out regarding herself, Wimpie Muller, Esmarie Wiid, or “The Judge” would be excluded from accessing such funding.

These actions have disrupted relationships with platforms including INAC, among others.

3. Protection of Constructive and Lawful Relationships

TSAA and its associates, including William Liebenberg, Ann Verster, and several other activists, have been committed supporters of Anna Maria Reitzinger and GFG in their efforts to improve the lives of living men and women.

These relationships are regarded as valuable and **will not be undermined** by any corporation or individual acting in bad faith.

4. Purpose and Invitation

This notice may be shared freely to assist those seeking clarity regarding the identity, intent, and purpose of The South African Assembly.

TSAA exists to empower men and women to live in dignity and abundance under common, customary, and natural law, applied consciously and lawfully in everyday life.
