Notice of REJECTION of the Proposed Amendment to the Constitution by Repealing Section 235 of the Constitution, Self-determination;

Kindly Take Notice That;

I Reject the Proposed Amendment to Remove and Repeal Section 235 from the Constitution in total.

You do not have the authority to alter or amend the Constitution in any way, shape or form, unless the express fully informed permission and consent has been given to you by we the people through a comprehensive national referendum; I have not given such permission;

Take Note That all power and authority is vested in and derived from we the people, and that “sovereignty itself remains with the people, by whom and for whom all government exists and acts” (Justice Thomas Stanley Matthews in *Yick Wo v Hopkins* [p 370]);

That, we the people are endowed by our Creator with inherent, pre-existing, natural, antecedent, unalienable, inalienable rights such as **Life, Freedom, Land and Property** which existed long before the fiction called “government”.

*Stand firm, then, and do not let yourselves be burdened again by a yoke of slavery.
Galatians 5:1*

Take Further Note with regards to Self-Determination;

We the people have the natural, inherent, inalienable God-given right to self-determine, to self-govern and are the absolute authority for our lives, and we have dominion over the earth;

And that all people, all volk, all cultures, the kindoms, kingdoms, queendoms, chiefdoms, clans, kraals, first nations people, any and all cultures on this land & soil South Africa,, shall make our own decisions with regards self-determination.

It Must Be Noted That the people's right to self-determination is natural, inherent unalienable, unquestionable, undisputable, creator-given and cannot ever be taken away; not ever;

Maxim: Your rights end where my rights begin.

A Simple Question is Asked of You;

Did our Creator God give you ownership of the people, of the land and the water, of the minerals and the plants, of nature and the animals?

Please provide proof if that is so. In the absence of any such proof, it appears that you have incorrectly assumed ownership.

Kindly Take Notice That we the people, the lawful owners and authority for the original un-incorporated South Africa and all derivatives thereof hereby expressly declare that we do not recognise REPUBLIC OF SOUTH AFRICA incorporated and it's franchises, departments and agencies as “lawful government”;

That what fronts as “lawful government” are merely private-for-profit businesses controlled by the globalist cabal.



Maxim: Fraud vitiates everything.

Take Further Notice of the Supreme Court Ruling 1795:

“In-as-much as every government is an artificial person, an abstraction, and a creature of the mind only, a government can interface only with other artificial persons. The imaginary, having neither actuality nor substance, is foreclosed from creating and attaining parity with the tangible. The legal manifestation of this is that no government, as well as any law, agency, aspect, court, etc. can concern itself with anything other than corporate, artificial persons and the contracts between them.” (S.C.R. 1795, (3 U.S. 54; 1 L.Ed. 57; 3 Dall. 54))

Therefore, no **COURT OF SOUTH AFRICA** or **GOVERNMENT OF SOUTH AFRICA** et al, has any jurisdiction over anything to do with the living people, nature, our planet, and any and all aspects of our life and life on this earth.

Please Take Note; we are not subject to your regulations and corporate governance.
